

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Dialogue and Monitoring Committee to facilitate Japanese investments to the State of Karnataka - reg.

Read: Proceedings of the meeting by Hon'ble Chief Minister with the Japanese Delegation on 4.11.2009.

PREAMBLE:

The Japan External Trade Organisation (JETRO) and Japanese companies are to promote Japanese investment in Karnataka, especially in and around Bangalore. The State Government is also very keen on soliciting Japanese investment in the state. A meeting was held under the Chairmanship of Hon'ble Chief Minister with the Japanese Delegation on 4.11.2009.

In the meeting it was decided to constitute a 'Dialogue and Monitoring Committee' under the Chairmanship of Chief Secretary to Government with senior officers of Govt. of Karnataka, JETRO representatives and Japanese company representatives as members.
