

GUIDELINES FOR ISSUAL OF APMC MARKET FEE (APMC CESS) EXEMPTION ELIGIBILITY CERTIFICATE TO NEW AGRO PROCESSING ENTERPRISES UNDER 2009-14 POLICY AND AN EXISTING INDUSTRIES WHO HAVE UNDERTAKEN EXPANSION / MODERNIZATION / DIVERSIFICATION PROGRAMME UNDER 2006-11 POLICY PERIOD AND 2009-14 POLICY PERIOD.

The State Government has enacted the Karnataka Agricultural Produce Marketing (Regulation and Development) (Amendment) Act 2011 and published vide Notification No: ಸಂಖ್ಯೆ.ಆಇ/43/ಶಾಸನ/2010 ದಿನಾಂಕ 6-4-2011.


The Amendment Act 2011 provides that the existing industries who have made investment under Expansion/Modernisation/Diversification under 2006-11 policy period shall also be exempted from payment of market fee, for a period of five year from the date of commencement of the Karnataka Agricultural Produce Marketing (Regulation & Development) (Amendment) Act 2011 subject to unit complying the stipulated conditions.

The amendment Act 2011 also provides that, no market fee shall be payable for a period of five years, four years and three years from the date of the commencement of the Karnataka Agricultural Produce Marketing (Regulation & Development) (Amendment) Act, 2011, in case of new agricultural produce processing industries and existing processing industries who undertake Expansion/Modernization/Diversification in Zone-1, 2 and 3 respectively as identified under Karnataka New Industrial Policy 2009-14, published in Government Order No.CI/223/SPI/2008 dated 28-02-2009, on the purchases of agricultural produce as specified in Sl. No. II, III, IV, VI, VII, IX and X of the schedule appended to the Act directly from farmers subject to unit complying the stipulated conditions.

Procedure to claim APMC Cess/Fees Exemption

The eligible Micro, Small, Medium Enterprises, Large and Mega enterprises shall apply to the Joint Director, District Industries Centre along with the following documents.


- a. Application in plain paper/ letter head
- b. Copy of the IEM acknowledgement Part II or Industrial license
- c. Copy of term loan sanction order, if any
- d. Copy of First sale Invoice
- e. Copy of the Project Report
- f. Copy of Single Window Clearance Committee approval letter if any.
- g. Land documents/ records
- h. List of machineries and their capacities.

The concerned, Joint Director, District Industries Centre after verification of the eligibility of the enterprise for APMC cess/ fee exemption, shall issue the eligibility certificate in respect of MSMEs and projects cleared in SLSWCC's and shall recommend the proposals cleared under SHLCC to Directorate for issue of eligibility certificates. The eligibility certificate shall be in the prescribed format i.e., as in Annexure - 24A, 24B, 24C separately for 2006-11 and 2009-14 policy periods.

The Joint Director, District Industries Centre shall furnish quarterly statement, indicating the details of cases issued with APMC Cess / Fees exemption certificates in the prescribed format as in Annexure-34.


